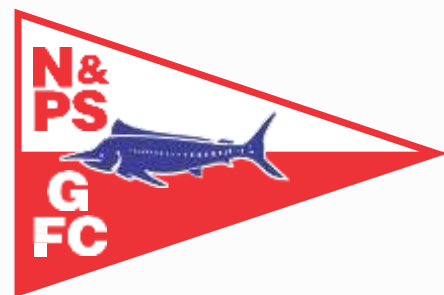

SECRETARY MANAGERS REPORT

Hi Members,

It is with great pleasure I report the happenings of the past 12 months.

Your club has produced a record profit for 2015 – 2016 financial year; the best result the club has seen financially since its formation, this result is a credit to our team of directors and staff, who for many years have put in the hard yards under some intense pressure.

As mentioned above financially your club is strong, but we cannot become complacent, we need to keep focus on industry changes and trends, to help capture the market and not get left behind.

Your board and management will continue to strive to improve your club, investing money in making your club more modern and also at the same time keeping it warm, welcoming and friendly.

Your club has achieved a profit of \$185,761.59 after depreciation, this result is excellent considering the current club environment, especially the amount of small clubs that have closed or amalgamated over the past 5 years. The treasurer will report in more detail but I would like to highlight some achievements.

- The clubs cash flow as mentioned above is very strong, the strongest it has been for over 15 years, we have increase our term deposit to \$213,873.98 and in total we have increased our cash position by \$161,419.40, total cash in the bank is \$396,295.95, what this means is your club board is working hard to financially secure your club for the future.
- Bar turnover has improved by significantly 12.8%, bar nett has improved by 28%, this sort of growth is achieved by producing first class food and service, our club caterer Steve & Andrea have given our club a great reputation in food service and product, this reputation continues today. Our bar Gross Profit percentage in our bar has continues to exceed industry standards at 60.3%, as mentioned in previous reports, this GP percentage is something we have worked hard on increasing by keeping a watch on product costs, working with our suppliers to give us a much better price and of course keeping our prices at a level that competes with the other outlets in our area.
- Bar wages have been closely monitored this year, with the help of the increase in turnover our wage percentage has dropped dramatically from 30.6% to 26.6%.
- Our electricity continues to drop, thanks to sourcing a much better agreement, we have again reduced this expense by 20%.
- Our depreciation expense has increased by 19%.

The board and management have some improvements planned for the coming year, to brighten the club house up, we also be looking at new bi fold doors which will open the whole club into the balcony, these constructions should be complete by the time our AGM comes around

As you are all aware the current environment is tough, even tougher for small clubs and it will continue to be tough, so we need to be able create an environment that will attract patrons to the club, and hopefully the improvements we have forecast will help achieve this.

The board and management will continue to concentrate on the key areas of your club to continue its profitability in these uncertain times.

The Garmin-Sylvania Marina Shootout has again been a huge success, this tournament has turned into the pinnacle tournament for all skippers to enter, this year we broke another record in angler participation and it is now become the largest game fishing tournament on the east coast of Australia.

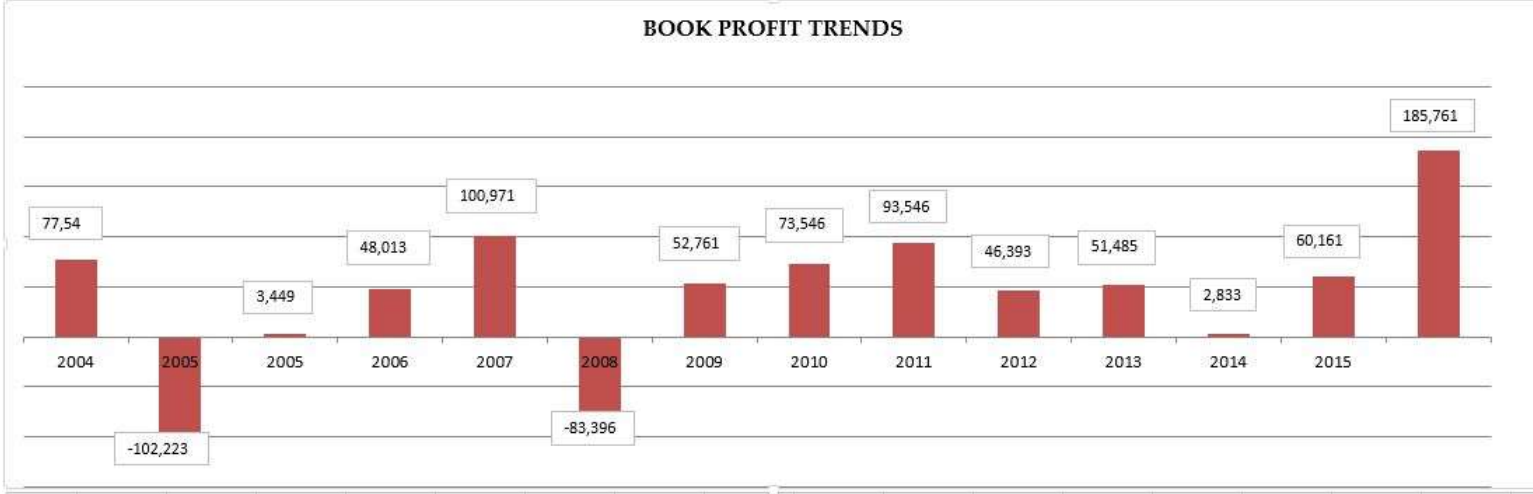

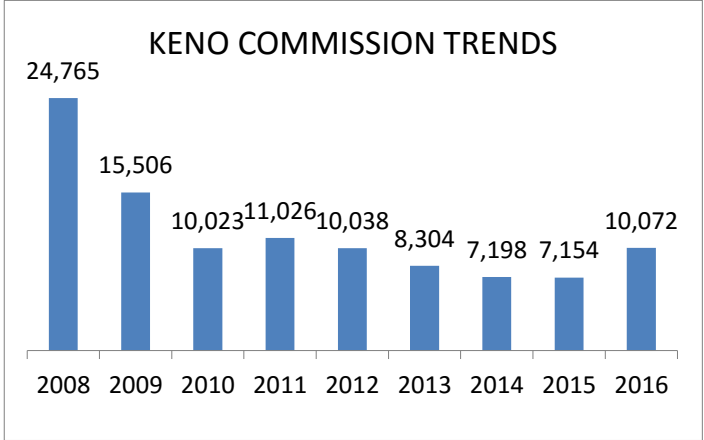

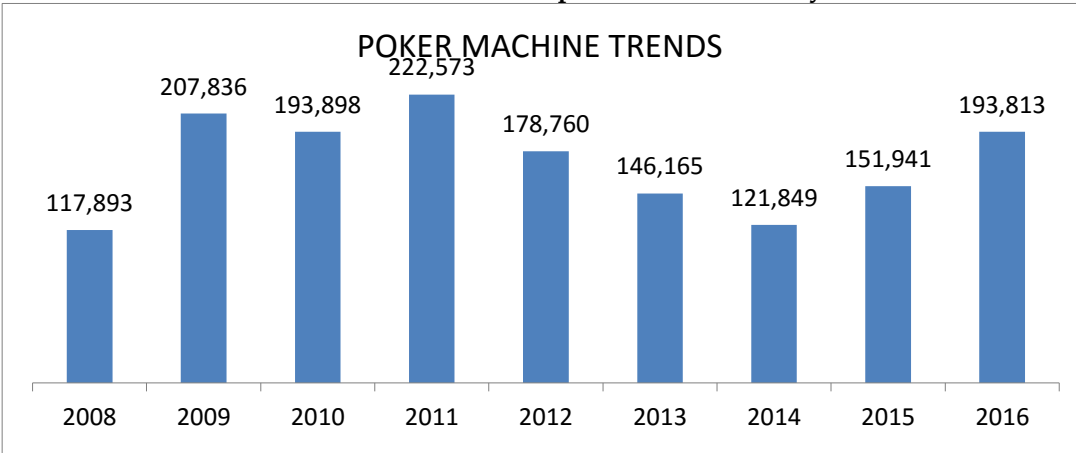
Book profit is up 208% from the 2015 year

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31ST MAY 2016

The financial statements cover Newcastle & Port Stephens Game Fish Club Limited as an individual entity, incorporated & domiciled in Australia. Newcastle & Port Stephens Game Fish Club Limited is a company limited by guarantee.

The financial statements were authorised for issue on 24th June 2016 by the directors of the company.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of preparation

These general-purpose financial statements have been prepared in accordance with Australian Accounting Standards and interpretations of the Australian Accounting Standards Board and the Corporations Act 2001. The company is a not for profit entity for financial reporting purposes under Australian accounting standards.

Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Accounting Policies

a) Property, Plant & Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, accumulated depreciation and any impairment losses.

Freehold Property

Freehold land and buildings are measured at their fair value based on valuations by external independent valuers.

Plant and Equipment

Plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than the estimated recoverable amount, the carrying amount is written down immediately to the estimated recoverable amount, and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset.

A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1, (j) for details of impairment).

Plant and equipment that have been contributed at no cost or for nominal cost are recognised at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised lease assets, but excluding freehold land, is depreciated on a straight line basis over the assets useful lives to the company commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the un-expired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised in profit or loss in the period in which they arise. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained surplus.

(b) Inventories on Hand

All inventories are valued at the lower of cost and current replacement cost.

c) Income Tax

The company has not provided for income tax, as it is currently exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(d) Leases

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight line basis over the lease term.

e) Employee Provisions

Short-term employee provisions

Provision is made for the company's obligation for short-term employee benefits. Short-term employee benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the amounts expected to be paid when the obligation is settled.

Other long-term employee provisions

Provision is made for employee's long service and annual leave entitlements not expected to be settled wholly within 12 months after the end of the annual reporting period in which the employees render the related service.

Long service leave entitlements have been calculated for employees with more than 5 year service. They have been calculated at the amount expected to be paid when liability is settled

The company's obligations for long-term employee benefits are presented as non-current employee provisions in its statement of financial position, except where the company does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

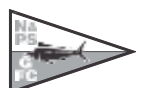

The net amount of GST recoverable from, or payable to the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented in the cash flow statement on a net basis.

(h) **Cash on Hand**

Cash on hand includes cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

(I) **Comparative Figures**

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

(j) **Impairment of Assets**

At the end of each reporting period, the company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, is compared to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in profit or loss.

Where the future economic benefits of the asset are not primarily dependent upon the assets ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of an asset's class, the entity estimates the recoverable amount of the cash-generating unit to which the class of asset belong.

Where an impairment loss on a revalued asset is identified, this is recognised against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that class of asset.

(k) **Accounts Receivable & Other Debtors**

Accounts receivable and other debtors include amounts due from members as well as rent receivable from tenants. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Accounts receivable are recognised at fair value.

(l) **Accounts Payable & Other Payables**

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the company during the reporting period which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(m) **Provisions**

Provisions are recognised when the entity has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.
