Greg and Mike in conjunction with David Litchfield and Hancock Sheetmetal, have supported the club in sponsoring the Shootout since its inception and supplied material either free of charge or at a very discounted price. They compete in both Interclub and Shootout every year, their commitment to the club is unquestionable.













UPPER FLOOR AND ROOF PLAN



SECRETARY MANAGERS REPORT

Hi Members.

It is with great pleasure I report the trading results of the past 12 months.

Well, it certainly has been a very interesting year, especially the last few months, with an environment that none would have expected.

Of course, your club was closed due to the pandemic for 9 weeks, I am happy to say we reopened from 4th June and the trade has been exceptional.

These are the kind of disasters or bumps in the road to why you should always be prepared, certain decisions over the years were made to protect the financial viability of your club if and when a disaster happens, your club was prepared financially for such an event, it has come out the other end healthy, I am sure there are a lot of other businesses that cannot say the same, unfortunately.

To assist our staff, we put together a small pantry of items so if they ever found themselves short of supplies, they could utilise the pantry, we also registered them through the Job keeper program.

We as landlords also supported our tenants, giving free rent for April and May, we continue to work with our tenants positively, helping them through this very tough time.

Your board and club management have again produced a very strong balance sheet, a balance sheet all members should be proud of.

I am pleased to reveal that your club has come out the other end with an excellent profit of \$76,676.00 after depreciation and amortization of \$159,420.00.

The club's current assets at the end of the year amount to \$424,784.00 and our current liabilities amount to \$100,975.00, showing that we are in a very strong financial position. Total assets amount to \$4,331,991.00 and our total liabilities are \$110,442.00, showing a very strong balance sheet, which will carry the club for years to come.

As you can see our depreciation has increased by \$21,000.00, this is mainly due to the renovation that took place last year, as mentioned by Troy, we have submitted a DA into the council, (The submission was made 1 week before lockdown) to extend the back area and establish an alfresco gaming area, it also creates more room inside the club, at the time of writing this report the DA was still before the council.

The coming year will be a year to watch and act, most businesses are in unknown territory and it will all depend on what happens after September 30th this year when Job keeper and Job Seeker finish and what effect this will have on unemployment and discretionary spending.

The treasurer will report in more detail, but I would like to highlight some areas.

The cash position is \$355,510.00, very similar to the beginning of the year, so we have a positive cash flow report. Total revenue has decreased slightly from last year. Total T/O \$1,848612.00, this turnover was achieved even after the club was closed for 9 weeks due to the pandemic.

Fishing memberships has stayed the same, after the huge increase last year, which means we are retaining our members, of course, thanks to our hugely successful tournament.

The Garmin Billfish Shootout has again been a huge success. All fishing members should be very proud that your club holds one of the finest tournaments in Australia.

As you all are aware it takes a lot of hard work and a good group of people to make a club this financially successful, I thank every member on the board, your contribution is appreciated.

You will see that there are 2 life member nominations for Mike Forbes and Greg Hancock, some members may not be aware of what these 2 gentlemen have brought to the club, they have contributed over 40 years combined, Greg 21 years and Mike as treasurer for 19 years, they both were brought in to help save the club from financial ruin by David Litchfield, as you can see by this financial report and many others over the years it was a masterstroke. Both gentlemen were instrumental in what we have today, dare I say if it wasn't for them and some others, this club may not be here, so I am very happy to see them being nominated and both are very worthy nominations.

To the staff of the club, I thank you for all your hard work and patience, especially during some very hard times. Our caterers Steve and Andrea have again been a major factor in our success, I would like to thank them and their team for producing quality and consistent food throughout the year.

In closing, I thank all members for their contribution and support over the last 12 months and look forward to another successful year in 2020-2021.


Book Profit for 2019 is down 38% in comparison to 2019

Poker Machine revenue is down 26% from the 2019 year










Annual Turnover is down 8% in comparison to 2019



NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31ST MAY 2020

The financial statements cover Newcastle & Port Stephens Game Fish Club Limited as an individual entity, incorporated & domiciled in Australia. Newcastle & Port Stephens Game Fish Club Limited is a company limited by guarantee.

The financial statements were authorised for issue on 25th June 2020 by the directors of the company.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of preparation

These general-purpose financial statements have been prepared in accordance with Australian Accounting Standards and interpretations of the Australian Accounting Standards Board and the Corporations Act 2001. The company is a not for profit entity for financial reporting purposes under Australian accounting standards. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Accounting Policies

a) Property, Plant & Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, accumulated depreciation and any impairment losses.

Freehold Property

Freehold land and buildings are measured at their fair value based on valuations by external independent valuers.

Plant and Equipment

Plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than the estimated recoverable amount, the carrying amount is written down immediately to the estimated recoverable amount, and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset.

A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1(j) for details of impairment).

Plant and equipment that have been contributed at no cost or for nominal cost are recognised at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised lease assets, but excluding freehold land, is depreciated on a straight-line basis over the assets useful lives to the company commencing from the time the asset is available for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable assets are:

Poker Machines 20%

Plant, Fixtures & Fittings 15% - 30%

Carpets 27%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised in profit or loss in the period in which they arise. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained surplus.

a) Inventories

All inventories are valued at the lower of cost and current replacement cost.

h) Income Tax

The company has not provided for income tax, as it is currently exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

c) Leases

The Company as lessee

At inception of a contract, the Company assesses if the contract contains or is a lease. If there is a lease present, a right-of-use asset and a corresponding lease liability is recognised by the Entity where the Company is a lessee. However, all contracts that are classified as a short-term leases (lease with remaining lease term 12 months or less) and leases of low value assets are recognised as an operating expense on a straight-line basis over the term of the lease.

Initially the lease liability is measured at the present value of the lease payments still to be paid at commencement date. The lease payments are discounted at the interest rate implicit in the lease. If this rate cannot be readily determined, the Entity uses the incremental borrowing rate.

Lease payments included in the measurement of the lease liability are as follows:

- fixed lease payments less any lease incentives;
- variable lease payments that depend on an index or rate, initially measured using the index or rate at the commencement date;
- the amount expected to be payable by the lessee under residual value guarantees;
- the exercise price of purchase options, if the lessee is reasonably certain to exercise the options;
- lease payments under extension options if lessee is reasonably certain to exercise the options; and
- payments of penalties for terminating the lease, if the lease term reflects the exercise of an option to terminate the lease The right-of-use assets comprise the initial measurement of the corresponding lease liability as mentioned above, any lease

The right-of-use assets comprise the initial measurement of the corresponding lease liability as mentioned above, any lease payments made at or before the commencement date as well as any initial direct costs. The subsequent measurement of the right-of-use assets is at cost less accumulated depreciation and impairment losses.

Right-of-use assets are depreciated over the lease term or useful life of the underlying asset whichever is the shortest. Where a lease transfers ownership of the underlying asset or the cost of the right-of-use asset reflects that the Company anticipates to exercise a purchase option, the specific asset is depreciated over the useful life of the underlying asset.

d) Employee Provisions

Short – term employee provisions

Provision is made for the company's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and annual leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

Other long-term employee provisions

Provision is made for employees' long service and annual leave entitlements not expected to be settled wholly within 12 months after the end of the annual reporting period in which the employees render the related service.

Long service leave entitlements have been calculated for employees with more than 5 years' service. They have been calculated at the (undiscounted) amount expected to be paid when liability is settled

The company's obligations for long-term employee benefits are presented as non-current employee provisions in its statement of financial position, except where the company does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current employee provisions.

f) Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Revenue from the rendering of services is recognised upon the delivery of the service to the Customers.

Interest revenue is recognised as it is received.

All revenue is stated net of the amount of goods and services tax (GST).

g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented in the cash flow statement on a net basis.

h) Cash and cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

i) Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

j) Impairment of Assets

At the end of each reporting period, the company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, is compared to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in profit or loss.

Where the assets are not held primarily for their ability to generate net cash inflows – that is, they are specialised assets held for continuing use of their service capacity – the recoverable amounts are expected to be materially the same as fair value.

Where it is not possible to estimate the recoverable amount of an individual asset, the entity estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Where an impairment loss on a revalued individual asset is identified, this is recognised against the revaluation surplus in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that class of asset.

k.) Accounts Receivable & Other Debtors

Accounts receivable and other debtors include amounts due from members as well as rent receivable from tenants. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Accounts receivable are recognised at fair value.

1.) Accounts Payable & Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the company during the reporting period which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

m.) Provisions

Provisions are recognised when the entity has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

n.) Critical Accounting Estimates and Judgments

The directors evaluate estimates and judgments incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained externally and within the company.

o.) Fair Value of Assets & Liabilities

The company measures some of its assets and liabilities at fair value on either a recurring or non-recurring basis, depending on the requirements of the applicable Accounting Standard.

Fair value is the price the Company would receive to sell an asset or would have to pay to transfer a liability in an orderly (i.e. unforced) transaction between independent, knowledgeable and willing market participants at the measurement date.

As fair value is a market-based measure, the closest equivalent observable market pricing information is used to determine fair value. Adjustments to market values may be made having regard to the characteristics of the specific assets or liability. The fair values of assets and liabilities that are not traded in an active market are determined using one or more valuation techniques. These valuation techniques maximise, to the extent possible, the use of observable market data.

To the extent possible, market information is extracted from either the principal market for the asset or liability (i.e. the market with the greatest volume and level of activity for the asset or liability) or, in the absence of such a market, the most advantageous market available to the entity at the end of the reporting period (i.e. the market that maximises the receipts from the sale of the asset or minimises the payments made to transfer the liability, after taking into account transaction costs and transport costs).

For non-financial assets, the fair value measurement also takes into account a market participant's ability to use the asset in its highest and best use or to sell it to another market participant that would use the asset in its highest and best use.

The fair value of liabilities and the entity's own equity instruments (excluding those related to share-based payment arrangements) may be valued, where there is no observable market price in relation to the transfer of such financial instruments, by reference to observable market information where such instruments are held as assets. Where this information is not available, other valuation techniques are adopted and, where significant, are detailed in the respective note to the financial statements.

p) New and Amended Accounting Policies Adopted by the Company Initial application of AASB 16

The company has adopted AASB 16: Leases retrospectively with the cumulative effect of initially applying AASB 16 recognised at 1 July 2019. In accordance with AASB 16 the comparatives for the 2019 reporting period have not been restated.

The company has recognised a lease liability and right-of-use asset for all leases (with the exception of short term and low value leases) recognised as operating leases under AASB 117: Leases where the Entity is the lessee.

The lease liabilities are measured at the present value of the remaining lease payments. The Entity's incremental borrowing rate as at 1 July 2019 was used to discount the lease payments.

The following practical expedients have been used by the Company in applying AASB 16 for the first time:

- for a portfolio of leases that have reasonably similar characteristics, a single discount rate has been applied;
- leases that have remaining lease term of less than 12 months as at 1 July 2019 have been accounted for in the same way as short-term leases:
- the use of hindsight to determine lease terms on contracts that have options to extend or terminate;
- applying AASB 16 to leases previously identified as leases under AASB 117: Leases and Interpretation 4: Determining whether an arrangement contains a lease without reassessing whether they are, or contain, a lease at the date of initial application
- not applying AASB 16 to leases previously not identified as containing a lease under AASB 117 and Interpretation 4.

The Entity's weighted average incremental borrowing rate on 1 July 2019 applied to the lease liabilities was 5.1%.
